Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Chapter 8, and other securities of any description, other than money deposited with a building society.

*NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body*




- (a) failure to register any disclosable pecuniary interest required to be registered under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act; or


