Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within meaning of the Financial Services and Markets Act 2000, Chapter 8, and other securities of any description, other than money deposited with a building society.

NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.

I understand that (without reasonable excuse);

(a) failure to register any disclosable pecuniary interest required to be registered under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act; or

- (b) to participate in any discussion or vote in any matter considered at a meeting where I have a disclosable pecuniary interest in the matter in contravention of Section 31(4) of the Localism Act; or
- (c) to knowingly or recklessly provide information under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act which is false or misleading;

is a criminal offence under Section 34 of the Localism Act, punishable by a fine not exceeding level 5 on the standard scale (currently £5,000), and disqualification as a Co-opted Member of the Parish Council or any other relevant authority for a period not exceeding five years.
