

4 Land

This means any beneficial interest in land within the area of the Town/Parish Council of yourself, or your partner.

NOTE: Land includes buildings, including your home. It does not include an easement, servitude, interest or rights in or over land which does not include the right for you or your partner (alone or with another) to occupy the land or to receive income.



5 Licences

This means any licence (alone or jointly with others) to occupy land in the administrative area of the Town/Parish Council held by yourself, or your partner, for a month or longer.

6 Corporate Tenancies

This means any tenancy where (to your knowledge) -

- (a) the landlord is the Parish Council; AND
- (b) the tenant is a body in which you, or your partner, have a beneficial interest;

 - (ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which you, or your partner, have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Chapter 8, and other securities of any description, other than money deposited with a building society.
