This means any contract made between yourself, or your partner, (or a body in which you, or your partner, have a beneficial interest), and the Parish Council -


- (a) under which goods or services are to be provided or works are to be executed; AND
- (b) which has not been fully discharged;

#### 4 Land

This means any beneficial interest in land within the area of the Parish Council of yourself, or your partner.

NOTE: Land includes buildings, including your home. It does not include an easement, servitude, interest or rights in or over land which does not include the right for you or your partner (alone or with another) to occupy the land or to receive income.



## 5 Licences

This means any licence (alone or jointly with others) to occupy land in the administrative area of the Parish Council held by yourself, or your partner, for a month or longer.

## 6 Corporate Tenancies

This means any tenancy where (to your knowledge) -

- (a) the landlord is the Parish Council; AND
- (b) the tenant is a body in which you, or your partner, have a beneficial interest;

## 7 Securities

This means any beneficial interest in securities of a body where -

(a) that body (to your knowledge) has a place of business or land in the administrative area of the Parish Council; AND

(b) either -

 (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued shared capital of that body; OR

(ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which you, or your partner, have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Chapter 8, and other securities of any description, other than money deposited with a building society. NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.

I understand that (without reasonable excuse);

- (a) failure to register any disclosable pecuniary interest required to be registered under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act; or
- (b) to participate in any discussion or vote in any matter considered at a meeting where I have a disclosable pecuniary interest in the matter in contravention of Section 31(4) of the Localism Act; or
- to knowingly or recklessly provide information under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act which is false or misleading;

is a criminal offence under Section 34 of the Localism Act, punishable by a fine not exceeding level 5 on the standard scale (currently £5,000), and disqualification as a Member or Co-opted Member of the Town/Parish Council or any other relevant authority for a period not exceeding five years.
