2 Sponsorship

Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000,

Chapter 8, and other securities of any description, other than money deposited with a building society.

NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.
