## 6 Corporate Tenancies

This means any tenancy where (to your knowledge) –

- (a) that body (to your knowledge) has a place of business or land in the administrative area of the Town/Parish Council; AND
- (b) either -
  - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued shared capital of that body; OR
  - (ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which you, or your partner, have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Chapter 8, and other securities of any description, other than money deposited with a building society.

**NOTE:** A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.
